

TERMS AND CONDITIONS: Mother's Day Hampers

Your participation in Silks Darwin MOTHER'S DAY HAMPERS promotion on Mother's Day 2022 (08/5/22), ('the Competition') constitutes deemed acceptance of the following terms and conditions:

1. By entering, you acknowledge that each entrant has an equal chance of winning the prize and the winner will be drawn by Silks Darwin.
2. The Promoter of the Competition is 'Silks Darwin'. 'Silks Darwin', reserves the right, at any time to verify the validity of entries and to disqualify any entrant who tampers with the entry process or who submits an entry that is not in accordance with these terms and conditions. Failure by the promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
3. The competition is open to members and guests of Silks Darwin
4. Members and guests are eligible to enter 'the Competition' when they spend a minimum of \$15 on food and/or beverage in the promotion period.
5. For every \$15 spent on food and/or beverage in the promotion period, Members and guests receive an entry ticket. For example:
 - i. When \$17 is spent, one entry ticket shall be awarded
 - ii. When \$35 is spent, two entry ticket shall be awarded
 - iii. When \$75 is spent, five entry ticket shall be awarded
6. Prize must be claimed by presenting photo ID to Silks reception.
7. \$15 is the minimum spend.
8. The promotion starts 10:00am on 8/5/22 and ends with the final draw.
9. It is the responsibility of the ticket recipient to complete entry and place in designated barrel.
10. Prizes will be drawn at Silks Darwin from 2:00pm on 8/5/22 in order of smallest to largest
11. Winners will be announced in venue and invited to claim prize.
12. If winner is not in venue, they will be contacted via details supplied on the entry ticket and given until 8:00pm Monday 9th May to claim prize.
13. If winner cannot be contacted for any reason, including (but not limited to) lack of contact details supplied, there will be a redraw and the process continued until a winner claims prize.
14. Entrants can win more than once on each draw day.
15. The valid entry drawn will win the designated prize.
16. Winning raffle tickets will be randomly selected on the day of the draw. The drawn raffle ticket will be the winner.
17. There is no replacement of lost winnings.
18. If the entrant loses their ticket, the ticket will not be reissued.
19. Silks Darwin reserves the right to disqualify any entrant reasonably suspected of forgery or tampering.
20. Any staff member employed by The Darwin Turf Club or Silks Darwin is eligible to enter but cannot collect their prize while on duty.
21. Entrants must be an Australian Resident and a Northern Territory Resident 18 years of age or older to be eligible to enter the competition.
22. If this competition is interfered with in any way, or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoters, the Promoters reserve the right, in its sole discretion, to the fullest extent permitted by law:
 - a. (a) to disqualify any entrant; or
 - b. (b) subject to any written directions from a regulatory (or other appropriate) authority to modify, suspend, terminate or cancel the Competition, as appropriate.
23. The name of the winner may be published and the winner may be asked to participate in any publicity regarding the competition – including real time social media updates, or images published in local media outlets.

The prize winner agrees that Silks Darwin accepts no responsibility or liability for any delay or failure to deliver a prize, or failure by Silks Darwin to meet any of its obligations in these conditions of entry or otherwise where delivery of a prize may be subject to delay. Silks Darwin will notify the winner as soon as possible and Silks Darwin will use its best endeavours to facilitate delivery as soon as possible.
