

TERMS AND CONDITIONS: SUPER CASH

Your participation in Silks Darwin SUPER CASH Gaming promotion 2024 ('the Competition') constitutes deemed acceptance of the following terms and conditions:

1. By entering, you acknowledge that each entrant has an equal chance of winning the prize and the winner will be drawn by Silks Darwin (the Promoter).
2. The Promoter of the Competition is 'Silks Darwin'. 'Silks Darwin', reserves the right, at any time to verify the validity of entries and to disqualify any entrant who tampers with the entry process or who submits an entry that is not in accordance with these terms and conditions. Failure by the promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
3. The promotion commences from 1pm Wednesday 3rd of January 2024. The promotion will reoccur weekly from 1pm – 5:00pm every Wednesday.
4. This promotion will run for a promotional period to be determined by management.
5. To be eligible to enter 'the Super Cash Competition' you must:
 - a. Be a Financial Silks Rewards Member.
 - b. Play Silks Darwin gaming machines from 1pm - 5:00pm Wednesday, and have your card inserted in the gaming machine at the time of draw.
 - c. Be present at the time of the draw to the claim prize.
 - d. \$40.00 cash draws will take place at Silks Darwin starting at 1pm, 1.20pm, 1.40pm, 2pm, 2.20pm, 2.40pm, 3pm, 3.20pm, 3.40pm, 4pm, 4.20pm, 4.40pm, 5pm (13 draws)
 - e. The winning machine number will be announced in the Silks gaming room– if the machine is being played without a card inserted, a re-draw will take place until the criteria is met.
 - f. To claim the prize, the player must remain seated at the drawn machine until the gaming cashier can confirm that it is being actively played by a Silks member with their membership card inserted, with credits remaining on the machine.
 - g. Entrants can win more than once if drawn out on a different machine.

7. By entering you consent to the promoter collecting your personal details and using images that may be used for promotional purposes.

 - a. to disqualify any entrant; or
 - b. subject to any written directions from a regulatory (or other appropriate) authority to modify, suspend, terminate or cancel the Competition, as appropriate.

Silks Darwin (including its officers, employees and agents) excludes all liability (including negligence) for any personal injury or any loss or damage (including loss of opportunity) whether direct, indirect, special or consequential, arising in any way out of the competition, including but not limited to:
 - a. any technical difficulties or equipment malfunction (whether or not under the promoter's control);

- b. any theft, unauthorized access or third-party interference;
 - c. any entry, prize, or claim for a prize that is late, lost, altered, damaged or misdirected (whether before or after receipt by the promoters) due to any reason beyond the reasonable control of the promoters;
 - d. any variation in prize value to that stated in these Terms and Conditions.
