

## **TERMS AND CONDITIONS: Deal or No Deal**

Your participation in Silks Darwin DEAL OR NO DEAL ('the Competition') constitutes deemed acceptance of the following terms and conditions:

- 1. By entering, you acknowledge that each entrant has an equal chance of winning the prize and the winner will be drawn by Silks Darwin (the Promoter).
- 2. The Promoter of the Competition is 'Silks Darwin'. 'Silks Darwin', reserves the right, at any time to verify the validity of entries and to disqualify any entrant who tampers with the entry process or who submits an entry that is not in accordance with these terms and conditions. Failure by the promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
- 3. To be eligible to enter 'the Competition' entrants must be a member of Silks Darwin.
- 4. Be eligible to enter 'the Competition' by playing a gaming machine and have Silks Membership card inserted between 6:00pm 8:30pm on Thursdays.
- 5. ONE virtual ticket will be created for every \$10 worth of Turnover on a gaming machine.
- 6. Members must be present to win.
- 7. The promotion commences from 6.30pm THURSDAY 4<sup>TH</sup> of April 2024. The promotion will reoccur weekly from 6.30pm − 8.30pm every THURSDAY.
- 8. This promotion will run for a promotional period to be determined by management.
- 9. A virtual barrel draw will take place at Silks Darwin starting at 6.30pm, 6.50pm, 7.10pm, 7.30pm, 7.50pm, 8.10pm, 8.30pm (7 draws)
- 10. The winning member will be announced in the Silks gaming room and has 2 minutes to present themselves to a gaming staff member
- 11. If no winner presents themselves a re-draw will take place. If no winner after the re-draw then the prize is forfeited.
- 12. To claim the prize, the winning member must randomly select a BOX and receive the prize OR risk the original prize by choosing a 2<sup>nd</sup> BOX.
- 13. If the player wishes to risk the original prize for a  $2^{nd}$  BOX, the winner must accept the prize of the  $2^{nd}$  BOX.
- 14. Once a prize is claimed, the BOX is to remain open.
- 15. Prizes are not redeemable for an alternate prize.
- 16. By entering you consent to the promoter collecting your personal details and using images that may be used for promotional purposes.

- 25. If this competition is interfered with in any way, or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoters, the Promoters reserve the right, in its sole discretion, to the fullest extent permitted by law:
  - a. to disqualify any entrant; or
  - b. subject to any written directions from a regulatory (or other appropriate) authority to modify, suspend, terminate or cancel the Competition, as appropriate.



- 26. Silks Darwin (including its officers, employees and agents) excludes all liability (including negligence) for any personal injury or any loss or damage (including loss of opportunity) whether direct, indirect, special or consequential, arising in any way out of the competition, including but not limited to:
  - a. any technical difficulties or equipment malfunction (whether or not under the promoter's control);
  - b. any theft, unauthorized access or third-party interference;
  - c. any entry, prize, or claim for a prize that is late, lost, altered, damaged or misdirected (whether before or after receipt by the promoters) due to any reason beyond the reasonable control of the promoters;

The promoter and staff accept no responsibility for loss, theft or damage to prizes once claimed.
