

TERMS AND CONDITIONS: CRACK THE CASE

Your participation in Silks Darwin CRACK THE CASE ('the Competition') constitutes deemed acceptance of the following terms and conditions:

1. By entering, you acknowledge that each entrant has an equal chance of winning the prize and the winner will be drawn by Silks Darwin (the Promoter).
2. The Promoter of the Competition is 'Silks Darwin'. 'Silks Darwin', reserves the right, at any time to verify the validity of entries and to disqualify any entrant who tampers with the entry process or who submits an entry that is not in accordance with these terms and conditions. Failure by the promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
3. To be eligible to enter 'the Competition' entrants must be a member of Silks Darwin.
4. Be eligible to enter 'the Competition' by playing a gaming machine and have Silks Membership card inserted between 5:00pm – 9:00pm on Thursdays.
5. ONE virtual ticket will be created for every \$10 worth of Turnover on a gaming machine.
6. Members must be present to win.
7. The promotion commences Thursday, 2 April 2026.
8. The promotion will reoccur weekly every THURSDAY and will run for a promotional period to be determined by management.
9. Draws every 30 minutes from 6pm – 9pm (7 weekly) via virtual barrel
 - a. 6:00pm
 - b. 6:30pm
 - c. 7:00pm
 - d. 7:30pm
 - e. 8:00pm
 - f. 8:30pm
 - g. 9:00pm
10. The winning member will be announced in the Silks gaming room and has 2 minutes to present themselves to a gaming staff member
11. If no winner presents themselves a re-draw will take place. If no winner after the re-draw then the prize is forfeited.
12. To claim the prize, the winning member will select one (1) of fourteen (14) cases and open it to reveal their cash prize.
13. The member will be given the choice to "Take the deal" or "No Deal" to select another case.
14. If the member says "No deal" they may select one (1) more case and win the prize in the 2nd case instead. Once a prize is claimed, the BOX is to remain open.
15. A maximum of two (2) cases per draw can be selected per member.
16. Each week, one (1) case will contain a "GOLDEN CASH BONUS" prize of \$200. If a member selects this case, they will receive the gold bonus cash amount on top of their selected base prize.
17. Once a case is open, it will remain open and cannot be selected again.
18. The GOLDEN CASH BONUS prize should be moved each week, using a random number generator prior to commencement of the draws.
19. Member will be awarded the prize amount immediately.
20. Prizes are not redeemable for an alternate prize.
21. By entering you consent to the promoter collecting your personal details and using images that may be used for promotional purposes.

 - a. to disqualify any entrant; or
 - b. subject to any written directions from a regulatory (or other appropriate) authority to modify, suspend, terminate or cancel the Competition, as appropriate.

Silks Darwin (including its officers, employees and agents) excludes all liability (including negligence) for any personal injury or any loss or damage (including loss of opportunity) whether direct, indirect, special or consequential, arising in any way out of the competition, including but not limited to:
 - a. any technical difficulties or equipment malfunction (whether or not under the promoter's control);
 - b. any theft, unauthorized access or third-party interference;
 - c. any entry, prize, or claim for a prize that is late, lost, altered, damaged or misdirected (whether before or after receipt by the promoters) due to any reason beyond the reasonable control of the promoters;
