

## TERMS AND CONDITIONS: EUREKA RICHES

Your participation in Silks Darwin EUREKA RICHES promotion ('the Promotion') constitutes deemed acceptance of the following terms and conditions:

1. By entering, you acknowledge that each entrant has an equal chance of winning the prize and the winner will be drawn by Silks Darwin (the Promoter).
2. The Promoter of EUREKA RICHES is 'Silks Darwin'. 'Silks Darwin', reserves the right, at any time to verify the validity of entries and to disqualify any entrant who tampers with the entry process or who submits an entry that is not in accordance with these terms and conditions. Failure by the promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
3. To be eligible to enter 'the Competition' you must:
  - a. Be a Financial Silks Rewards Member.
  - b. Members enter by correctly inserting member card into gaming machine and having active credit on machine from 6pm - 9pm on Sundays.
4. Members earn Virtual Barrel entries from 6pm-9pm every Sunday.
5. Draws every 30 minutes from 7pm – 9pm (5 weekly) via virtual barrel:
  - a. 7:00pm
  - b. 7:30pm
  - c. 8:00pm
  - d. 8:30pm
  - e. 9:00pm
6. At the draw time, winning member has 2 minutes to present themselves to staff in gaming
7. If prize remains unclaimed within two (2) minutes, the venue will redraw until an eligible and winner is present and identified to claim their prize.
8. The member must choose their character (1 of 5) to reveal the number of Gold Nuggets they will flip. They will then be automatically awarded the accumulated cash amount from the Gold Nuggets they flip on the prize board by the cashier/staff.
9. If the 'bomb' is revealed, the members turn concludes and they only win the amounts they revealed before the bomb. If the bomb is revealed on their first pick, the member is awarded a \$30 consolation prize.
10. If the x2 multiplier is revealed, the member multiplies their total accumulated prize by 2 (multiplier counts as one of their turns).
11. At the end of each draw, all cutouts are shuffled and placed back on the prize board. The chosen Character from each draw will remain off the prize board for remainder of the draws.
12. A staff member issues the winning member with the cash amount.
13. By entering you consent to the promoter collecting your personal details and using images that may be used for promotional purposes.
14. Entrants must be present at the time of the draw to win.
15. Entrants can win more than once
16. There is no replacement of lost winnings.
17. By entering this promotion, the entrant is aware of the likelihood of losing, and understand the associated risks and that the entrant exercises control over their gambling behaviour and that Silks Darwin accepts no responsibility or liability

19. Silks Darwin reserves the right to disqualify any member reasonably suspected of forgery or tampering.

21. To be eligible to enter the competition, entrants must be Australian Residents and 18 years of age or older.

22. If this competition is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoters, the Promoters reserve the right, in its sole discretion, to the fullest extent permitted by law:
  - a. to disqualify any entrant; or
  - b. subject to any written directions from a regulatory (or other appropriate) authority to modify, suspend, terminate or cancel the Competition, as appropriate.

Silks Darwin (including its officers, employees and agents) excludes all liability (including negligence) for any personal injury or any loss or damage (including loss of opportunity), whether direct, indirect, special or consequential, arising in any way out of the competition, including but not limited to:
  - a. any technical difficulties or equipment malfunction (whether or not under the promoter's control);
  - b. any theft, unauthorized access or third-party interference;
  - c. any entry, prize, or claim for a prize that is late, lost, altered, damaged or misdirected (whether before or after receipt by the promoters) due to any reason beyond the reasonable control of the promoters;
24. On claiming the prize, the winner accepts full responsibility for loss, theft or damage to the prize. The promoter and staff accept no responsibility for loss, theft or damage to prizes once claimed. The prize is only available on the day of the promotion only and will not be accepted beyond this date.
